Information to be made publicly accessible shall not contain commercially sensitive information or personal data that are not to be disclosed under the Union data protection rules.

In line with the Transparency Policy of the EIB and EIF, Investment Committee decisions for such cases, which have not been disclosed in the EU Guarantee Approvals document as of 31 March 2024, are published below. This is after the projects have been signed or if these projects are not subject to a confidentiality agreement between the EIBG and the promoters anymore.

It is to be noted that the respective Conclusions and Scoreboards of the below operations have been made publicly available only when the consent for disclosure has been obtained from the relevant counterparty.
